

SITE LICENSE AGREEMENT

This License Agreement is made this _____ day of _____, ___, by and between Asiatica Association ONLUS ("Asiatica Association") and _____ ("Subscribing Institution").

Provided the Institution agrees to be bound by the following Site Licence Agreement conditions, on completion of the registration procedure, the Institution will be granted a Site license in respect of each journal which is available electronically online.

1 Scope of License. Institutional Subscriber Use Restrictions.

1.1 Under this Agreement, Subscribing Institution is granted a nonexclusive, revocable, nontransferable right and license to access and use the subscribed Asiatica Association Journal(s) made available to Subscribing Institution on the World Wide Web via the Subscribing Institution's Internet protocol addresses (IP addresses) up to the authorized number of workstations, and, in connection with the foregoing, to permit Subscribing Institution's Authorized Users to access the Journal(s) and make the uses described in the "Rights of Use" statements.

1.2 "Authorized Users" are the employees, faculty, staff, and students officially affiliated with the Subscribing Institution or patrons of the Subscribing Institution's library facilities. This includes occasional users who access Asiatica Association Journal(s) through stations physically located on the site and under the control and administration of the Subscribing Institution. Authorized Users also includes persons affiliated with remote sites or campuses of the Subscribing Institution that are administered from the Subscribing Institution's site or campus, but not persons affiliated with remote teaching campuses that have separate administrative staffs.

1.3 For the avoidance of doubt, individual members of the Subscribing Institution will automatically cease to be Authorized Users immediately upon ceasing to be members of the Subscribing Institution

1.4 The Subscribing Institution's library facilities are not permitted to share hard or electronic copies derived directly or indirectly from the electronic edition of the publications for the purpose of inter-library loan.

1.5 This Agreement does not permit use of the Journal(s) on more than one campus or sharing of this resource among a regional consortium. If the Asiatica Association at any time determines in its sole discretion that the range of IP addresses claimed by the Subscribing Institution represents more than one campus, it may terminate this Agreement forthwith by notice to the Subscribing Institution.

1.6 The Subscribing Institution is responsible for taking reasonable measures to prevent access by unauthorized persons to its IP addresses, and is responsible for terminating any unauthorized access of which it has actual notice or knowledge. The Subscribing Institution will not be held responsible for uses of the subscribed Journal(s) that are contrary to the guidelines stated above, provided that such uses are without its express or implied consent, and provided that it promptly notifies Asiatica Association of any such use of which it becomes aware and takes all reasonable steps to terminate such activity. The Subscribing Institution agrees to cooperate with Asiatica Association in any investigation of unauthorized access or use. Asiatica Association will not bring an action against an Authorized User without first consulting the Subscribing Institution.

1.7 The Subscribing Institution is responsible for taking all reasonable steps to ensure that all Authorized Users abide by the provisions of paragraphs 2.1 and 2.2 of this Site License.

1.8 The Subscribing Institution is responsible for terminating an Authorized User's access to the Journal(s) after becoming aware of any breach of this Site License.

2 Rights of Use.

2.1 Under the terms of this Site licence each Authorised User is granted the non-exclusive right to download, display, view and print off a single copy ony of each item of the Material for such Authorised User's personal non-commercial use in the course of the Institution's business only. The copy made of an article or an article fragment must preserve the author's name, title, journal name, publisher, and copyright statement.

2.2 Save only for the purposes specified in 2.1 above Authorised Users may not use, store transiently or permanently on any medium, modify, transfer, transmit, reproduce, redistribute, retransmit, loan to any third party, publish, republish or otherwise exploit or use for any prohibited use the whole or any part of any article or abstract or index constituting the material by any means.

3 Warranty

The Journal(s) are provided on an "as is" and "as available" basis. Asiatica Association gives no warranty, express or implied, and makes no representation that:

3.1 The Journal(s) will be of satisfactory quality, suitable for any particular purpose or for any particular use under specified conditions, notwithstanding that such purpose, use, or conditions may be known to Asiatica Association; or

3.2 that the online service will operate error free or without interruption or that any errors will be corrected; or

3.3 that the Material published in the Journal(s) or otherwise accessible through the online service is either complete or accurate.

4 Limitation of Liability

4.1 The entire liability of Asiatica Association whether in contract, tort, by statute or otherwise to the Subscribing Institution or Authorised Users shall be the refund of any fee paid to Asiatica Association for electronic access.

4.2 In no circumstances will Asiatica Association be liable for damages including, without limitation, damages for loss of data or corruption of data, loss of programs, loss of business, goodwill, or other incidental, consequential or indirect losses of any nature arising out of the use, or inability to use the Journal(s) including without limitation losses arising from any errors, omissions, or other inaccuracies in or corruption caused whether by transmission processing or otherwise to the Material published in the Journal(s) or otherwise made accessible through the Journal(s).

4.3 In the distant future, if very old articles must be archived offline by Asiatica Association for efficiency, there may be an additional charge to cover the cost of retrieving old articles. In the foreseeable future, all published articles will be available online.

5 Termination

Either party may terminate this Site licence Agreement forthwith by serving written notice on the other in the event that the other party commits a material breach of this Agreement and in the case of a breach capable of remedy fails to remedy the same within 30 days of a request so to do. Asiatica Association reserves the right at any time in relation to any one or more of the Journal(s):

5.1 to cease electronic production and publication and/or to withdraw electronic access;

5.2 to modify the subscription fee after each year of subscription, and/or to change the electronic access system at any moment.

6 Governing Law and Jurisdiction

The terms and conditions of this Site licence are governed by Italian law and the Milan (Italy) courts shall have jurisdiction.
